C60d - special rate for non-metered offtake

Conditions for application of the rate:

The rate may be granted only if it is not technically and economically possible to properly meter the offtake using the distributor's metering device and the total installed input at the offtake point does not exceed 1000W.

The rate is set as a fixed monthly payment for every 10 W (and part thereof) of installed input, and amounts to 65,03 CZK

Notes:

1) The maximum payment of the price for support of electricity for the offtake point for the billed period is determined as the product of the amount of CZK 495/MWh and the total quantity of electricity consumed from the distribution system
